For parents/carers who wish to make a voluntary contribution, the following arrangement has been set up on PMX, our online payment platform, to facilitate this.

Process for Collection of Voluntary Contributions

- The voluntary contribution option will be made available to parents/carers in your payment screen (PMX payments shop payment options voluntary contribution); we aim to send one message per family
- We have suggested a donation of £35 per family per term. This sum can be increased/decreased/paid termly/annually or not at all.
- This sum will appear in the screen alongside a donation box.
- You can increase this sum by using the donation box in addition to the £35 donation. You can also decrease the £35 if you prefer, by using the part-pay box.
- In addition, if you are a UK taxpayer, Gift Aid increases the value of your donation by 25%, because the school can reclaim the basic rate of tax on your gift at no extra cost to you. Just tick the Gift Aid box on PMX when you make your donation.
- To simplify the process, the youngest child's name only will be shown in the screen against which any voluntary contribution on behalf of the family can be made.

Gift Aid

By ticking the 'Gift Aid' box on the PMX online payment screen when making your voluntary contribution you are confirming that you are a UK taxpayer and have read and agreed the declaration below.

Charity Gift Aid Declaration – Multiple Donations

Gift Aid at 25p for every £1 donated is reclaimed by the school from the tax you pay for the current tax year. Your address is needed to identify you as a current UK taxpayer (this we would automatically generate from the student contact page on CMIS, our management information system).

In order to Gift Aid your donation you must tick the 'Gift Aid' box on the PMX online payment screen when making your voluntary contribution.

Declaration:

If you pay Income Tax at the higher or additional rate and want to receive the additional tax relief due to you, you must include all your Gift Aid donations on your Self-Assessment tax return or ask HM Revenue and Customs to adjust your tax code.

PMX ParentMail Online Payments - How do I buy an item from school?

You will be able to see Payments as an option in your parent feed on either your computer or through the ParentMail App. If you have a notification, it means your school have invited you to pay for something, or have notified you of a new payment item which is now available for you to buy or pre-order.
